I'd like to take a moment to thank you all for your patience & understanding this last quarter. We, like many other industries at the moment are facing the realities that short staffing bring. As the team & I here at mybookworks continue to work hard to meet your expectations, we thank you for your continued support.

As we approach closer to Christmas we thought it would be a great opportunity to remind our clients of some important considerations (including GST, Income Tax and FBT) when planning Christmas parties, gift giving to clients and suppliers and paying Christmas bonuses.

# **Client & Employee Gifts**

- If you keep your gifts under \$300 each, your purchases will remain exempt from FBT. This means \$299.00 *inclusive* of GST. These still may be not deductible for Income Tax purposes.
- Gift Cards or Vouchers up to the value of \$300 are not considered entertainment and thus exempt from FBT. Again, this means \$299.00 inclusive of GST
- Consider gifting trade tools, equipment or professional development course that would otherwise have been a tax deduction.
- When paying a Christmas Bonus rather than a gift, this is processed through payroll. PAYG Withholding & super will also apply.

### **Christmas Celebrations**

 When planning your end of year party for employees, their partners, suppliers, clients & customers, you need to consider if it could be classed as entertainment. If classed as entertainment, business deductions & GST are not able to be claimed.

## **Building Award Changes**

The Fair Work Commission has updated the National Training Wage Schedule in the Building Award. The changes will apply from the first pay period on or after 1 Nov 2022. For more information head to FairWork.
